

CENTRAL FLORIDA WATERCOLOR SOCIETY (CFWS) SHOW STANDARDS FOR JURIED SHOWS

Standards and guidelines for artwork displayed in CFWS Juried sponsored exhibits are as follows:

- Eligible work must be water based media executed in an aqueous manner on paper, treated paper or paper mounted on board.
- All artwork must be original and done from the artist's own photos and design, plein air, still life, or abstract. No prints.
- No images copied from magazines, seed or floral catalogues are permitted.
- No paintings done in workshops or done under class instruction are permitted.
- Each artist is responsible for the delivery of their own paintings to the exhibit.
- Artists must be current paid-up members of the CFWS.
- Maximum size including the frame is 32" x 40".
- **Paintings should be framed as follows:**
 - Simple frames - metal or wood (ornate or bright enamel colors are unacceptable).
 - Mats should be neat and clean, and neutral (white, off white, pale gray, etc...).
 - Frame must have wire on the back to hang - no sawtooth hangers
 - Plexiglass is required for safety reasons.

Paintings not properly framed, will not be hung.

- Show Identification cards/labels for the paintings will be provided.
- There will be a "hanging" committee to hang and label the paintings.
- There will be a listing (brochure) of paintings submitted and accepted.
- Not all paintings submitted are guaranteed to be displayed. Final approval will be made by the Hanging Committee and The City Arts Factory. CFWS and the "hanging" committee reserve the right to refuse any work deemed inappropriate or in non-compliance with these guidelines for the show.
- For this show, paintings will be judged by a nonmember of CFWS.
- This show may have specific additional entry conditions that members must follow.

Entry conditions:

A Donation of 30% of net sales is required to be made to the Downtown Arts District (a 501(c)(3) corporation) from this juried show.

Official Entry form must be used for this show.
